PLEASE READ THE INSTRUCTIONS CAREFULLY

1. Applications which do not give the necessary information will not be accepted.
2. A stamped and addressed envelope should be sent with the application.
3. If the applicant did not study in a recognised school in the previous year this fact should be stated in the space allotted.
4. Signature by a Guardian can be accepted only with a written authorisation by father if parents live abroad.
5. The date of birth in the application should agree with the date of birth in the Transfer Certificate. Request for alteration will not be entertained later.
6. The filled in Application form along with the Xerox Copy of Birth Certificate should be submitted on the date of Entrance Test.
7. Transfer Certificates need be produced only by those who are selected for admission. As it will not be possible for the Headmistress to meet the parents of all girls who apply for admission, it will be easier for her to make the admissions with fairness if she does not interview, any parent or guardian at all before the admissions are made. Parents are therefore earnestly requested not to seek for interview, whether formal or informal, during the period when admissions are being considered. Parents who wish to mention any special facts to be considered are requested to write the same and attach it to the applications.
